## PROFESSIONAL SERVICES

**BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF ..... \$ 1895**

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

**USE OF FACILITIES AND STAFF FOR FUNERAL CEREMONY in the Chapel ..... \$ 595**

Services include coordinating the funeral arrangements, supervision and direction of the funeral ceremony.

**USE OF EQUIPMENT AND STAFF FOR FUNERAL CEREMONY at Church..... \$ 595**

Service includes coordinating the funeral arrangements, supervision and direction of the funeral ceremony.

**USE OF FACILITIES AND STAFF FOR MEMORIAL SERVICES in the Chapel ..... \$ 595**

Service includes coordinating the memorial service arrangements, supervision and direction of the memorial service.

**USE OF EQUIPMENT AND STAFF FOR MEMORIAL SERVICES at church ..... \$ 595**

Service includes coordinating the memorial service arrangements, supervision and direction of the memorial service.

**USE OF EQUIPMENT AND STAFF FOR GRAVESIDE SERVICES ..... \$ 595**

Service includes accompaniment of remains to cemetery, supervision and direction of the Graveside service.

**USE OF FACILITIES AND STAFF FOR VIEWING .....(Per Day)..... \$ 295**

Services include set-up and use of visitation area, placement of remains, display . of floral arrangements and supervision of visitation.

**ADDITIONAL FEE for weekend, holiday or evening services..... \$ 500**

## PROFESSIONAL SERVICES (Continued)

### EMBALMING ..... \$ 495

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Embalming provides temporary preservation and disinfection of the body and generally eliminates most health hazards associated with human remains. *A California licensed embalmer completes this procedure.*

## ALTERNATIVE SERVICES

**FORWARDING REMAINS TO ANOTHER FUNERAL HOME..... \$ 2495**

Our charge includes: basic services of funeral director and staff, a proportionate share of overhead costs, removal of remains; embalming of remains, if relevant, and local transportation. This charge does not include visitation or ceremonies.

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME..... \$ 2495**

Our charge includes: basic services of funeral director and staff, a proportionate share of overhead costs, care of remains, local transportation of remains to funeral home and to cemetery or crematory. This charge does not include visitation or ceremonies.

**DIRECT CREMATION ..... \$ 1750**

Our charge for a direct cremation (without ceremony) includes basic services of funeral director and staff, a proportionate share of overhead costs, removal of remains, transportation to crematory, necessary authorizations, and cremation if relevant.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a fiberboard container.

**Direct Cremation with container provided by purchaser..... \$ 1675**

**Direct Cremation with alternative container (fiberboard)..... \$ 2025**

(Cremation completed within 7 working days from receipt of signed Certificate of Death and acceptance by the State Department of Health)

(Cremation completed within 3 working days from receipt of signed Certificate of Death and acceptance by the State Department of Health)

**Direct Cremation with Memorial Service, alternative container (corrugated fiberboard)**

**IMMEDIATE BURIAL .....Available from \$3590 to \$13,300**

Our charge for an immediate burial (without ceremony) includes basic services of funeral director and staff, a proportionate share of overhead costs, removal of remains, and local transportation to cemetery during regular business hours and when no date or time is specified by the family.
